

Butte County Election November 2014

Vote YES on Measure A – A is OK

Measure A = reasonable amounts of medical pot per Prop. 215

- ✓ Allows patients to grow a reasonable amount of Medical Marijuana
- ✓ Curtails the out of control, illegal for-profit pot trade
- ✓ Limits the size of pot gardens to 150 sq ft or 10' x 15' max (= several plants)
- ✓ Lets anyone complain about bad pot grows; protects your anonymity
- ✓ Lets your elected Supervisors represent you to adjust laws with the times

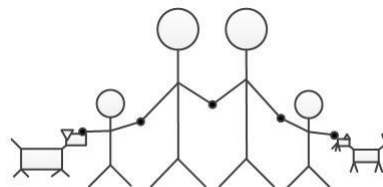
Vote NO on Measure B – B is BAD

Measure B = *insane amounts of pot for profit = crimes + damage*














- ✓ Allows up to 99 plants per parcel (same as today), beyond medical needs
- ✓ Encourages the illegal, pot-for-profit industry to come to Butte County
- ✓ Pretends to be about patients' needs – it's really about growers' profits
- ✓ Will result in continued crimes, environmental damage and nuisance
- ✓ Will continue to let growers "take over" neighborhoods
- ✓ Restricts who can complain – must live within 1500 ft. Code enforcement won't investigate grows unless you file a complaint. ***MANY DON'T COMPLAIN FOR FEAR OF RETALIATION.***
- ✓ Prevents Supervisors from modifying the law in the future. Your elected representatives won't be able represent you! It will require an initiative to change. This can be very expensive; *only those with money will be able to influence the law!* It turns democracy over to the "highest" bidder.

Plant counts under Measure A are estimates only. Actual yields depend upon many factors. For reference: "...50-square-foot garden could hold two reasonably large plants that between them could produce up to 10 pounds of usable cannabis a year. The 100-square-foot garden could hold four plants and the 150-square-foot operation could hold six reasonably large plants." *Source:* http://www.oroillemr.com/news/ci_24914176/butte-county-supervisors-move-tighten-pot-garden-rules
